Reviewed wetland replacement plan applications, exemption determinations, boundary and type determinations as related to enforcement actions. Completed a review of all WRPs approved by Scott County LGUs to determine compliance with WCA rules. Provided follow-up assistance to the DNR on aerial investigation of potential violations. Provided site review and prepared RO's for 5 sites. Attended wetland delineation training. Reviewed 20 wetland delineation for compliance with 87 Manual.

Made contact with City of Prior Lake, City of Shakopee and Elko/New Market to review with staff the WRP's that appeared to be out of compliance with WCA rules. Obtained follow-up information from these LGU's. Completed restoration order for 1 new CDO and conducted a site review on a potential violation. 12/31/09
